

Pilot project – joint Nordic Cooperation (Denmark, Norway and Iceland)

Dear potential suppliers,

The project group for the joint Nordic procurement would like to invite potential suppliers in the joint Nordic procurement to an information and dialogue meeting.

The meeting is reserved for suppliers with an authorization to market, which are potential suppliers of the listed pharmaceuticals, please see the appendix for further information.

The suppliers will have the opportunity to give feedback to project members after the information meeting in individual meetings. The purpose of the meetings is to enable the suppliers to give individual feedback to the members of the joint Nordic project group. The members of the joint Nordic project group will not provide further information about the procurement during the dialogue meetings. Information about the procurement will only be given in the information meeting, and not in the dialogue meetings afterwards.

The project group would like to receive feedback from the suppliers regarding the requirements concerning the neck diameter (please see the appendix for further information), possible challenges with obtaining a market authorization for the pharmaceuticals in all three countries, possible challenges with the delivery of pharmaceuticals to any of the three countries and any other challenges which might arise. The project group kindly ask the suppliers to reflect upon these questions prior to the dialogue meeting in order to make the meeting as efficient as possible.

Time and place The meeting will take place Friday the 28th of September 2018 from 10.00 – 12.00 at Adina Apartment Hotel Copenhagen, Amerika Plads 7, 2100 Copenhagen.

Dialogue meetings will take place between 11.00-13.00 in the offices of Danske Regioner, Dampfærgevej 22, 2100 København Ø (2. minutes' walk from the Adina Apartment Hotel). Meetings will be held in meeting room 1, 5 and 6.
